#### **Answers To Typical Questions:**

#### What is "Construction & Demolition Debris"?

Construction & Demolition Debris or "rubble" is any type of waste associated with buildings, driveways, sidewalks or other kind of physical structure. Items are defined as materials that were once physically attached, or used to build homes, remodel or demolish a home or other structure. These materials include: structural steel, concrete, bricks, lumber, plaster, plasterboard, insulation, shingles, roofing felt, floor & ceiling tile, asphalt, pipe, wire, carpet, wallpaper and paint & caulk containers (empty and dry). This type of waste will not be accepted at the Transfer Stations after July 1st. Refer to the information at the bottom of this page for locations and options for disposal.

#### What if I want to clean out my garage or clean up my yard?

Materials or "junk" in your garage or around your property that are not physically attached to your home or other out buildings are not considered construction & demolition debris. These waste items will be accepted at the Transfer Stations. Examples of these items include: Furniture, wire fencing, lawnmowers, weed-eaters, appliances or white goods, playground equipment, toys, mattress & box springs, garden hose, plastic pool liners and metals. Miscellaneous containers or pots are acceptable provided they are empty and dry.

#### What if I remodel a room in my house or add an addition or deck?

These types of waste materials are considered construction & demolition debris and will not be accepted at the Transfer Stations after July 1st. Refer to the information at the bottom of this page for locations and options for disposal.

#### Can I still dispose of small quantities of scrap wood waste and other bulky items?

YES! Scrap wood waste and other bulky items will still be accepted in small quantities from homeowners. The quantity will be limited to a single 55 gallon size can per vehicle per week. This waste should be cut in small pieces less than 4 feet in length. Examples of this type of material may include: lumber, drywall, glass, plastic sheeting, plasterboard, tile and sawdust. Please remember pick-up truck loads, trailers or quantities exceeding a volume of 55 gallons of these materials will not be accepted at the Transfer Stations after July 1st.

#### What is "Commercial Waste"?

It has always been our policy not to accept any commercial waste or contractor waste. These waste materials include any type of refuse, garbage, construction & demolition debris, brush or bulky materials that are generated from a business arrangement or "for hire" building contractor, contract hauler, property manager, landscaper, lawn care business or farmer.

#### Transfer Station List Of Acceptable Material:

- 1. Household trash in bags or garbage cans
- 2. Washers, dryers and other appliances—clean & refrigerator lines uncut
- 3. Passenger car & light truck tires 17" diameter or less. No Rims.
- 4. Furniture & other bulky items
- 5. Glass bottles & jars
- 6. Plastic bottles
- 7. Aluminum & tin cans
- 8. Newspaper
- 9. Corrugated cardboard
- 10. Magazines, catalogs & phone books
- 11. Used motor oil & antifreeze
- 12. Yard waste—brush less than 4" diameter & 6' in length
- 13. Used clothing
- 14. Scrap metals

#### Transfer Station List Of Unacceptable Material:

- 1. Construction & demolition debris (rubble)
- 2. Commercial or business waste
- 3. Animal carcasses (Environmental Health 410-758-2281)
- 4. Hazardous substance (MDE 800-633-6101 x 3343)
- 5. Firearms, ammunition & explosives (Fire Marshall 410-822-7609)
- 6. Gas cans or tanks, helium, propane or freon containers
- 7. Stumps or brush over 4" diameter and 6' length
- 8. Burned materials
- 9. Broken Lead Acid Batteries
- 10. Farm waste
- 11. Dirt or mulch
- 12. Any tire on a rim
- 13. Site Attendants reserve the right to reject any other material or oversize loads based on inspection at the time of delivery.
