- \_\_\_ (d) Use or permit any animal to be used for the purpose of fighting, raised for the purpose of fighting, or organize or participate in any type of animal fighting.
- \_\_\_ (f) Inflict unnecessary suffering or pain upon an animal under the individual's charge or custody, or unnecessarily fail to provide the animal with nutritious food in sufficient quantity, necessary veterinary care, proper drink, air, space, shelter, or protection from the elements.
- \_\_\_ (g) Leave any domestic animal unattended in a standing or parked vehicle in a manner that endangers the health or safety of the animal.
- \_\_\_ (h) Shoot any domestic animal, except as provided under § 9-30 of this chapter or to humanely destroy such animal because of sickness, disease, or injury.
