#### Dear Property Owner:

The County Commissioners invite you to the above referenced public hearing to discuss impacts to your Class C vacant property (unimproved with a valid soil percolation test) in the Southern Kent Island Wastewater Subdistrict. As a vacant property owner in this subdistrict, your property is subject to **County Resolution 14-07** and the following assessments:

There are two options available to you to pay this assessment:

# Option 1 – Pay Assessment Upfront

Cl---- C A -----

- \$2,320.00 assessment on or before October 1, 2018
- \$30 per quarter vacant lot O&M fee commencing October 1, 2018

## Option 2 – 10-year Deferral of EBP Principle

- Amortize the base cost (\$2,320) over 20 years at 1.0% (\$33/quarter)
- \$30 per quarter vacant lot O&M fee commencing October 1, 2018

O Years 1 thru 20 – Commencing October 1, 2018

Total per quarter	\$ 63.00
O&M Vacant Lot Credit*	\$ -60.00*
O&M Fee	\$ 90.00
Assessment – Base Cost	\$ 33.00

The assessment, once levied, is transferable to future property owners if the property is sold before the assessment is paid in full. Also note once the assessment is levied, the action is final and it must be paid. If you are still considering the option of voluntarily combining adjacent lots to avoid multiple assessments, we have extended this deadline to October 1, 2018.

Prepayments on the assessment balance will be allowed without penalty however the assessment balance will not be re-amortized, only the term of the assessment will be reduced.

The County will begin accepting building permit applications for review on August 1, 2018 however none will be issued until October 1, 2018.

<sup>\*</sup> The Vacant Lot Credit is only applied while the lot is vacant and unimproved. Once your vacant lot is improved and connected to the sewer, the vacant lot credit is not applicable and the O&M fee will adjust to \$90/quarter.
