

COUNTY ORDINANCE NO. 13-23

A BILL ENTITLED

AN ACT CONCERNING Compensation of the Board of County Commissioners of Queen Anne's County;

FOR THE PURPOSE of revising and increasing the compensation of the County Commissioners of Queen Anne's County, Maryland; eliminating compensation to the County Commissioners for serving as the Queen Anne's County Sanitary Commission; and generally updating, revising and increasing the compensation for the office of the County Commissioners of Queen Anne's County, Maryland effective beginning at the next term of office;

BY AMENDING Sections 4-5 and REPEALING Section 24-4. B of the Code of Public Local Laws of Queen Anne's County, Maryland;

SECTION I

BE IT ENACTED BY THE COUNTY COMMISSIONERS OF QUEEN ANNE'S COUNTY, MARYLAND that Section 4-5. A of the Code of Public Local Laws be amended to read as follows:

§4-5. Compensation.

A. Salary. Each County Commissioner is entitled to an annual salary of \$25,000.00.

~~(1) \$10,250 in 1995;~~

~~(2) \$10,500 in 1996;~~

~~(3) \$10,750 in 1997; and~~

~~(4) \$11,000 in 1998 and in each subsequent year.~~

B. Expenses. Each County Commissioner is entitled to reimbursement for actual expenses incurred in the performance of duties on:

(1) Submission of a voucher; and

(2) Approval of the County Commissioners.

SECTION II

BE IT FURTHER ENACTED that Section 24-4. B of the Code of Public Local Laws be and is hereby REPEALED and Section 24-4 of the Code of Public Local Laws shall hereafter read as follows:

§24-4 Sanitary Commission.

A. Composition and jurisdiction. To carry out this Part 1, the Sanitary District shall be under the jurisdiction and control of the County Commissioners who shall sit as the Sanitary Commission.

~~**B. Salary of members.** In addition to compensation as a County Commissioner, each member of the Sanitary Commission shall receive a salary of:~~

~~(1) In 1995; \$3,250;~~

~~(2) In 1996; \$4,000;~~

~~(3) In 1997; \$4,740; and~~

~~(4) In 1998 and thereafter; \$5,500.~~

SECTION III

BE IT FURTHER ENACTED that this Act shall take effect at the commencement of the next term of office of the County Commissioners of Queen Anne's County.
