DEFINITIONS

1. YARD METERS:

Meters used to calculate water usage which does not enter the wastewater collection system. Not used in the calculation of wastewater usage.

NOTES

1. The rates contained herein shall annually increase by six and one-half percent (6.5%) for sewer and by five and one-half percent (5.5%) for water on July 1 of each year unless the County Commissioners determine by resolution prior to July 1 of each year that the rates will increase by a lesser percentage.
2. Newly created lots after January 1, 2001 will be charged allocation fees as specified in the KNSG Wastewater and Water Rate Schedules.
3. Any other fees, not specifically shown within this rate schedule, will be as determined within the KNSG Wastewater and Water Rate Schedules.
