RESOLUTION NO. 06-09

A RESOLUTION ADOPTING THE KENT NARROWS COMMUNITY PLAN UPDATE RECOMMENDED FOR ADOPTION BY THE QUEEN ANNE'S COUNTY PLANNING COMMISSION WITH THE ASSISTANCE OF A CITIZENS ADVISORY COMMITTEE ON MAY 15, 2006; PURSUANT TO THE POWER AND AUTHORITY CONTAINED IN ARTICLE 66B OF THE ANNOTATED CODE OF MARYLAND.

WHEREAS, in March, 2005 a Citizens Advisory Committee (CAC) consisting of the eight Kent Narrows Development Foundation Board Members and four local residents was appointed to review and update the 1992 Kent Narrows Community Plans and to make recommendations to the Queen Anne's County Planning Commission;

WHEREAS, in November, 2005, a draft plan was forwarded by the CAC to the Queen Anne's County Planning Commission following input from citizens, discussions and analysis of the community, natural resources, economic development opportunities, infrastructure, growth and development concepts for the area and consultation and input from the County Department of Planning and Zoning and consultants from the firm of Johnson, Mirmiran & Thompson;

WHEREAS, following work-sessions, review pursuant to Article 66B of the Annotated Code of Maryland, a public informational meeting on March 16, 2006 and a public hearing on April 12, 2006 the Planning Commission recommended the adoption of a new Kent Narrows Community Plan;

WHEREAS, the proposed Kent Narrows Community Plan conforms to the requirements of Article 66B, Section 3.05 of the Annotated Code of Maryland, would implement the visions set forth in Section 1.01 of Article 66B and would promote the health, safety and welfare of the citizens of Queen Anne's County, Maryland.

NOW THEREFORE, BE IT RESOLVED by the County Commissioners of Queen Anne's County, Maryland, as follows:


Section 1. The County Commissioners are acting pursuant to the authority of Article 66B of the Annotated Code of Maryland as the local legislative body of Queen Anne's County, Maryland.

Section 2. The Kent Narrows Community Plan recommended for adoption by the Queen Anne's County Planning Commission, May 15, 2006 be and is hereby ADOPTED and the same together with other Community Plans and the Queen Anne's County Comprehensive Plan


shall constitute the plan for Queen Anne's County as required by Section 3.05 of Article 66B of the Annotated Code of Maryland.






