
**Public Comment:**

Election Director's Report  
March 24, 2022

Primary Date Change

The Court of Appeals has made the decision to hold the primary election on July 19, 2022. We at the local level have been working on the logistical issues created by the changing of the election calendar. We have spoken with all of our Early Voting and Election Day polling places to ensure the new dates will be reserved for our use. We are quite fortunate that we did not run into any major challenges with our sites and the new dates.

Election Judges

We currently have 131 people that have shown interest and signed up to be an election judge. With the change in election dates we lost but also gained a few. Training classes will be conducted April 26th - April 30th.

Candidate Filing

The candidate filing deadline has been extended again to April 15, 2022 by 9pm. As of today, we currently have 36 local candidates that have filed and 1 that has withdrawn their candidacy.
