- Jeff wanted to speak about the disruption of the Chesapeake Republican Women's meeting, Dianna Waterman says Robin Saks with the Maryland Voter Integrity Group was speaking about statistics and paper ballots, they seemed to think that our county commissioners can opt out of SBE protocol for elections. They want paper ballots to be hand counted or hand tallied. Jeff cited the law listed below and in summary elections in the state of Maryland are governed by the State Board of Elections.

§ 9-101. Use of certified system in polling places and for absentee voting

(a) In general. -- The State Board, in consultation with the local boards, shall select and certify a voting system for voting in polling places and a voting system for absentee voting.

(b) Use in all counties. -- The voting system selected and certified for voting in polling places and the voting system selected and certified for absentee voting shall be used in all counties.

(c) Acquisition. -- The State Board shall acquire:

(1) the voting system selected and certified for voting in polling places; and

(2) the voting system selected and certified for absentee voting.

- Bill Seth disclosed contributions he has made to a couple of campaigns, he was advised by SBE to make the board aware.
- Crystal will send out updated information regarding the election dates and locations.
